In 1990 I joined the Sittingbourne Branch. Having passed the Parade Marshals Course and the Branch Management Course, I was elected as the founding Chairman of the Somme Branch in 2003.

I believe that now, like never before, we need a coalition of the old and the new to rapidly build and deliver the 21st Century Royal British Legion and that is what I would bring if elected as your National Chairman.

I am the proud father of a Fusilier son, who has recently left the Army – this gives me close experience and understanding of what recent leavers are looking for and of how much their experience of military service differs from that of many of you, our current members and our beneficiaries. This has to be a driving force for how we adapt and evolve in these next few years.

I offer eight years of broad and deep experience of the RBL group at the most senior level across the RBL itself, the NMA, Poppyscotland and perhaps most importantly after three years as Vice Chair and now three years as Chair of the Membership Council, proudly representing all of you and your interests. Military Career

I joined the Royal Regiment of Artillery as a Junior Leader at the age of 16 in 1963 and saw service in the United Kingdom, West Germany, Northern Ireland and Hong Kong. I was awarded the British Empire Medal in 1973 for services whilst serving with my Regiment in the Ardoyne, Belfast. I was commissioned from the ranks in 1982 and subsequently served as a staff officer in several Headquarters and as a Quartermaster of two discrete Royal Artillery Regiments. In 1996 I was promoted to Lieutenant Colonel and appointed to command a major support unit. My last posting was as a Senior Staff Officer responsible for Personnel Matters with the Defence Academy in Shrivenham.

Head of Governance and Administration - The Royal British Legion

On retirement from the British Army in 2001, after 37-years of service, I joined the Royal British Legion as the Head of Governance & Administration. As Secretary to the then National Council (now the Board of Trustees) and the Executive Board, I established the role as the nexus of communication for the National Officers, Trustees, the Directors, County Chairmen, Legion staff and other Ex-Service Charities. My responsibilities included the coordination of all aspects of Annual Conference, managing the corporate insurance and overseeing the Legion's international affairs. As Project Manager of the relocation of the Head Office within London, I delivered a £26m project on time and within budget. In June 2010 (after a nine-year tenure), I opted for early retirement and transferred my Legion Membership from the Wiltshire County Holding Branch to the Stapleford & Berwick Branch.

Trustee – The Royal British Legion

I was elected as a Trustee in May 2014. During my first three-year tenure I was a Member of the Property Committee and the Branch Property Trusts Trustee Committee. I was re-elected in 2017 and was entrusted with the Chairmanship of the Property Committee and the RBL International Committee (from 2018), I was appointed National Vice Chairman in September 2019 and Director of Poppyscotland in November 2019.

Lynda Atkins - Curriculum Vitae

My time as a Trustee and County Chair has shown me that the Membership of the Legion is its greatest strength. We need to find better ways to work across all parts of our organisation so that we truly are 'One Legion'. We can, and do, achieve great things together but much more is possible. In particular, I want to see much better communications and engagement with our Members who have so much to offer in our work to support our beneficiaries and to champion Remembrance. My life so far has given me many opportunities to work with and help others: being able to serve The Royal British Legion at the highest level as its National Vice Chairman would be the greatest opportunity yet.

I come from a service family. My Dad was in the RAF so I grew up living at RAF stations in the UK and around Europe. I have always felt at home with the forces, as for much of my life I lived as part of the Armed Forces Family. I know first-hand all the benefits and challenges of life in a service family.

Uniformed Service

When the time came for me to look for a career, applying to join the RAF seemed a natural thing to do. In 1981 began a short service commission as an Admin officer. During my time in the RAF I served at Lyneham while it was the UK airhead for the Falklands War and then in Northern Ireland, where I was the RAF Schools Liaison Officer for the province, based at RAF Aldergrove. My job took me to quite a few areas which would otherwise have been out of bounds and I had the privilege of working closely with members of the other services. Other posts included working at the RAF Personnel Management Centre at Innsworth, recruiting in the South East of England and finally running the accounts office at the RAF College, Cranwell. I left as a flight lieutenant after serving for 8 years.

When I left the RAF I joined the NHS as a personnel manager and also joined the TA. As I was living and working in Northampton, that was 118 Recovery Company, a REME TA unit based there. They didn't put me in charge of the big vehicles, but I did command HQ Company, which made sure people got fed and paid. I served for 3 years with the TA before work got too busy for me to give enough time to TA training.

My time in the RAF and then the TA gave me a set of skills which I have used throughout my life and enormous respect for all those who serve.

Working in the NHS

On leaving the RAF I put my forces training to good use and qualified as a Chartered Personnel Manager. I worked in the NHS as a Director of Personnel and then as Director of Corporate Development which combined planning and expanding services as well as managing staff. Having worked in acute hospital and community services, I transferred into the Department of Health in the late 1990s. My final hospital-based job was a secondment from there as Director of Operations at Stoke Mandeville Hospital in 2001. While at the Department of Health, I supervised health services across several counties and led a team helping to get new hospitals built across South East England. That included working with ministers as a senior civil servant at the Department of Health as well as lawyers, construction companies and banks.

I was able to learn how to work in and with complicated organisations during my time in the NHS and at the Department of Health, balancing lots of different points of view, but always with the people we were there to help – patients and their families – at the front of our thinking. I also had first-hand experience of working with national politicians and how complicated that can get!

In 2003 the Department of Health was reorganized and I chose to take redundancy. I took the opportunity to set up my own business working on planning hospital construction projects. I also stood, successfully, for election to our local town council and later, in 2008 was also elected as an independent county councillor. As a town councillor I was privileged to be chosen as Mayor of Wallingford, the town I live in, in 2005 and 2015. As a county councillor I was able to work with The Royal British Legion and other service charities on topics such as the Armed Forces Covenant and was appointed as the Military Champion for RAF Benson. I stood down as County Councillor in September 2019 when I was deeply honoured to be appointed a Deputy Lieutenant of Oxfordshire: representing Her Majesty The Queen on behalf of the Lord Lieutenant of Oxfordshire. I am the Military Liaison for the Oxfordshire Lieutenancy and lead on The Queen's Award for Voluntary Service. I'm also a member of the Steering Group for the Oxfordshire Civil Military Partnership Board and the County Chair for the South East Reserve Forces and Cadets Association (SERFCA).

Over my 15 years as a councillor I developed an understanding of how local government works and how it can be encouraged to work with veterans and the armed forces. As a Deputy Lieutenant I liaise with all the military units in a county where more than most people think of the Armed Forces are based.

My business opportunities slowly declined over the years, so in 2012 I was offered and accepted a job working for our local MP. I remained independent politically and was responsible for much of the case work – particularly the more complicated and difficult cases – that cropped up. *I learned how complicated some people's problems can be, and how different agencies need to work together to really deliver the help that is needed*. I did that job until 2015 when, having been a member of the Legion for many years, I became the Oxfordshire County Chair, a role I was honoured to hold until May 2019 when I became a co-opted Trustee before being elected as a Trustee in 2020. In 2016 I left the Town Council for family reasons in order to free up some of my time and later closed down my company. I have, along with the SSAFA Oxfordshire Chairman, run the county Veterans Forum for the past 4 years, bringing together all those in Oxfordshire who work with veterans, from local government, the NHS, charities and the armed forces. That is going from strength to strength and each year more people join us as they see the value of working together for those we serve.

As a Trustee of The Royal British Legion I am also Vice Chair of the Membership Council and a Trustee of the National Memorial Arboretum. Both roles enable me to work with staff and members to do the best we can to support the Legion.

In summary ...

My career has never worked out the way I thought it would, but my service in the RAF and TA helped to prepare me for both the good experiences and the challenges. I hope it also gave me the experience and skills that I hope will help me to be a successful National Vice Chairman for The Royal British Legion.

Personal Statement

You will note that I have two election statements for 2022, this one for re-election as a Trustee and the other for election as your National Vice Chairman. I seek your vote for both roles. By May 2022, I will have served on the Board of Trustees for four years 3 months, initially by co-option in 2018 and then by election in 2019. As a Trustee I have experienced the challenges of recent years, been part of the extremely difficult decision making that has to take place, often disputed by those perhaps not in possession of the full facts. The changes that were implemented late 2019, early 2020 saw the RBL come out of the pandemic in mid-2021 in a much stronger position than its contemporaries, able to help a wider range of beneficiaries in a much more cohesive manner. The role requires absolute personal integrity. I acknowledge that there is always more to do and I believe communication is key, particularly where change is concerned, but always within the legal constraints which the Trustees and the Charity are subject to. Along with overseeing the strategic direction of the Charity, continuing the implementation of our One Legion Strategy and executing the results of the Governance Review, there are three things that I wish, as a Trustee, to address in the next three years:

- 1. Ensure that the RBL remains relevant in the minds of the public which leads to retaining their moral and financial support.
- 2. Increase the attraction of the Charity to all generations by exploring individual membership running alongside the current requirement to be a Branch member. The younger generations think and act in a different manner and require a different membership or volunteer experience and
- 3. Embrace diversity and inclusion; ensuring that the RBL meets the needs of, and understands, the whole veteran community.

RBL Experience

Like many of you, I have been an RBL member for many years. My motivation to become involved with the RBL centres on "giving back" to those who need help after, or because of, their Service. My own Service was generally overseas where the opportunity to join in was limited, either due to location or to pace of work. However, on settling back in the UK, my RBL journey began with my local branch. I now have substantial leadership and management experience within TRBL covering all levels of TRBL from Branch, through County Chairmanship, Membership Council Representative to the Board of Trustees. I have experience in dealing with most RBL activities including welfare, finance, membership, Remembrance, Legion clubs, understanding issues related to complaints, property lease issues and the implementation of specialist policies. I have been a member of five of the seven major committees of the Board of Trustees; previously on Finance, Governance and Membership Council (as a Trustee I was appointed vice chair); currently on Audit & Risk plus Property (purchase and sale of commercial buildings). During the co-option period of my Trusteeship I took up the role of strategic adviser to the Directorate for Membership and Volunteering, the RBL

Project Management Office and the Veterans Gateway. I have experience of subsidiaries of the RBL Group; previously a Trustee and director of the National Memorial Arboretum and currently Chairman of the RBL- Republic of Ireland (and chair of its related company) plus Chairman of the Irish Ex Servicemen's Trust which is a Foreign & Commonwealth Office funded Trust, managed through the RBL. I have successfully conducted informal resolutions at both Branch and County level and, as a Trustee, been both a member and chairman of Investigation Panels on behalf of the Legion Complaints Committee. All of these roles result from being a Trustee; all require time to carry out and therefore my current commitment to the charity is significant and I willingly give that time.

Board and Leadership experience

My most recent board experience has been the 4 years 3 months that I have served with the RBL with the roles and responsibilities identified above. Simultaneously I am currently the Mayor and leader of my local Council. This comprises objective councillors with no political affiliations. Councillors are strong and independently minded, some with robust and successful business backgrounds. I have led this Council through the recent difficult times. It requires significant people skills to get individuals to work together for the common good and we have been successful. I have overseen a review of all of the Councils governing documents and policies, ensuring that the Local Government code of conduct was adopted by the Council for the first time, the equality and diversity policy was fit for purpose and that a third party expert company was engaged to deliver our health and safety, data protection and information security support. I was deputy mayor and deputy Council leader during the early part of the pandemic and led over 100 of the Towns community resilience response volunteers, ensuring that every one of the over 12,000 residents had the support they required. In the latter part of my military career I was the armed forces representative on the National Council of the Institute of Explosives Engineers 2002-2006; after returning from the USA, I was elected back to the Council for the period Apr 2009-2016. I chaired the legal & procedural, education and training committees at various times and was vice president of the Institute for two and a half years Dec 13-Apr 16. I was a board member of the UK Standards Setting Body for Explosives, Munitions and Search occupations 2003-06 and 2009-16, being board chairman 2009-11. I am a graduate of the RBL National Leadership Course

Career Highlights

I completed 32 years commissioned service deploying on Operations in the Middle East, Africa and Northern Ireland. My Counter-IED skills have been well recognised. I have experience working in the Joint Service and International arenas. I have served an exchange tour with the Canadian Forces, including the African operational experience; three years as a liaison officer in the Pentagon (being present during the 9/11 attack); been a specialist adviser to the Governor of Bermuda; worked on the UK Joint Staff and as a specialist advisor to the Multinational Corps Commanding General in Iraq. I was head hunted to be a civilian advisor to NATO, based in the USA. Subsequently I became a Director for a multinational Defence Sector company; finally owning and running a successful management consultancy business. Personal Statement

You will note that I have two election statements for 2022, this one for re-election as a Trustee and the other for election as your National Vice Chairman. I seek your vote for both roles. By May 2022, I will have served on the Board of Trustees for four years 3 months, initially by co-option in 2018 and then by election in 2019. As a Trustee I have experienced the challenges of recent years, been part of the extremely difficult decision making that has to take place, often disputed by those perhaps not in possession of the full facts. The changes that were implemented late 2019, early 2020 saw the RBL come out of the pandemic in mid-2021 in a much stronger position than its contemporaries, able to help a wider range of beneficiaries in a much more cohesive manner. The role requires absolute personal integrity. I acknowledge that there is always more to do and I believe communication is key, particularly where change is concerned, but always within the legal constraints which the Trustees and the Charity are subject to. Along with overseeing the strategic direction of the Charity, continuing the implementation of our One Legion Strategy and executing the results of the Governance Review, there are three things that I wish, as a Trustee, to address in the next three years:

- 1. Ensure that the RBL remains relevant in the minds of the public which leads to retaining their moral and financial support.
- 2. Increase the attraction of the Charity to all generations by exploring individual membership running alongside the current requirement to be a Branch member. The younger generations think and act in a different manner and require a different membership or volunteer experience and
- 3. Embrace diversity and inclusion; ensuring that the RBL meets the needs of, and understands, the whole veteran community.

RBL Experience

Like many of you, I have been an RBL member for many years. My motivation to become involved with the RBL centres on "giving back" to those who need help after, or because of, their Service. My own Service was generally overseas where the opportunity to join in was limited, either due to location or to pace of work. However, on settling back in the UK, my RBL journey began with my local branch. I now have substantial leadership and management experience within TRBL covering all levels of TRBL from Branch, through County Chairmanship, Membership Council Representative to the Board of Trustees. I have experience in dealing with most RBL activities including welfare, finance, membership, Remembrance, Legion clubs, understanding issues related to complaints, property lease issues and the implementation of specialist policies. I have been a member of five of the seven major committees of the Board of Trustees; previously on Finance, Governance and Membership Council (as a Trustee I was appointed vice chair); currently on Audit & Risk plus Property (purchase and sale of commercial buildings). During the co-option period of my Trusteeship I took up the role of strategic adviser to the Directorate for Membership and Volunteering, the RBL

Project Management Office and the Veterans Gateway. I have experience of subsidiaries of the RBL Group; previously a Trustee and director of the National Memorial Arboretum and currently Chairman of the RBL- Republic of Ireland (and chair of its related company) plus Chairman of the Irish Ex Servicemen's Trust which is a Foreign & Commonwealth Office funded Trust, managed through the RBL. I have successfully conducted informal resolutions at both Branch and County level and, as a Trustee, been both a member and chairman of Investigation Panels on behalf of the Legion Complaints Committee. All of these roles result from being a Trustee; all require time to carry out and therefore my current commitment to the charity is significant and I willingly give that time.
