FOYSM UPDATE

In 2021 The National Memorial Arboretum required all memorial plot holders to take on full responsibility for We opted for an the maintenance of plots. arrangement whereby NMA staff look after the Y Service plot for payment annually of around £1300. Our Friends of the Y Services Memorial (FOYSM) scheme generates an income for this overhead where members make a small monthly payment to a ringfenced account. These small amounts, as little as £3.00 (some pay more) soon add up and along with some annual pledges including a generous £500 from the Intelligence Corps Association (ICA) we have so far been able to cover the cost of this maintenance. Encouraged by the ICA donation we have now made approaches for financial support for the plot to the Royal Naval Association, the Royal Signals Association, the WRAC Association and the Royal Air Responses Force Association. from these approaches, which we hope will be successful, will be reported in future issues. A BIT OF HISTORY

No matter which branch of the armed forces you served with at some point you will have experienced (or have it yet to come) the 'Transition to civilian life' or more usually 'resettlement.' Following the end of World War Two it was simply 'demob.' (for demobilisation). Over the years those leaving the armed forces have been given help and advice to varying degrees and some left well prepared others not so. In the army it was not unusual for the job of resettlement to be given to a passed over major who also had responsibilities for the fencing club, families, the basketball team, regimental dustbins and fire precautions. Advice took the form mostly, of the departing soldier being handed several leaflets and being wished good luck. More recently transition to civilian life has been contracted out to a civilian firm: The Career Transition Partnership (CTP). CTP is a partnering agreement between the Ministry of Defence and Right Management and provides resettlement services for those leaving the Royal Navy, Army, Royal Air Force and Royal Marines and also acts as an intermediary for employers wishing to hire Service leavers.

Leaving the Armed Forces can, in some respects, be like starting again from scratch. For those who have completed 22 or more years having joined up at 18, they are too old to start as an apprentice but too young to retire. The CTP understands how complicated creating a new life can be, and provides advice on all aspects of civilian life including; approaching the job market; how to claim benefits; housing; health and education; pensions and interviewing skills. Advice, guidance and support are available from the CTP two years before discharge until two years after leaving Service, if the individual is eligible in accordance with current policy.

Straight after World War Two ,servicemen and women were demobbed in order according to age, length of service and whether or not they were married or single and returning to an occupation in a trade which would contribute to the reconstruction of the country's infrastructure. How much help did these heroes get to 'resettle?

Here's an extract from a late 1940s pamphlet:

RELEASE LEAVE AND YOUR UNIFORM

While you are on release leave your position is just the same as if you were on leave from your unit, except that you may take up civilian employment straight away and need not wait until the end of your leave, and that for health and pensions insurance purposes you are treated as a civilian from the date your leave begins. If you want reinstatement with your old employer you must apply promptly.

You are being allowed to take away with you certain articles of uniform. You may wear uniform up to the date of the termination of your release leave unless you are going abroad. Officers wishing to wear it after that date for some special occasion or reason should apply in writing to the War Office (A.G.4c.) giving particulars. These articles of uniform divested of all badges may be dyed, or otherwise altered so as to be of use to you in civilian life. Officers should, however, bear in mind that in the event of their being recalled to the Service, they will not be eligible for another outfit allowance.

Of course, times have changed and you see very few people out and about wearing dyed uniforms!
