#### KING HONOURS BRANCH MEMBER DAVID WHIMPENNY

Branch member, Lt Colonel (retd) David Whimpenny, was awarded the OBE in the King's New Year Honours List for 2024. The honour, made to recognise the achievements and service of extraordinary people across the UK, is for David's voluntary services to the Royal British Legion.

David has been a member of the Legion for 25 years having joined our Branch at the dedication of the Y Services Memorial at the National Memorial Arboretum (NMA) on 17 Sep 1998 and has held a variety of appointments at Branch, County, District and National level becoming a RBL board trustee in 2013, a post he held for 9 vears.

He was appointed chairman of the NMA in 2014, a position he held for eight years. During this award-winning period he oversaw two construction projects: the remodelling of the Remembrance Centre and the development of the Aspects events and conferencing facility. #### THE OBE

The Most Excellent Order of the British Empire (OBE) is a British order of chivalry, rewarding contributions to the arts and sciences, work with charitable and welfare organizations, and public service outside the civil service. It was established on 4 June 1917 by King George V and comprises five classes across both civil and military divisions, the most senior two of which make the recipient either a knight if male or dame if female. There is also the related British Empire Medal, whose recipients are affiliated with, but not members of, the order.



#### THE DAVE STREET AWARD

Long serving Branch member Dave Street who sadly died in July 2023 was for several years Chairman of National Branches District and at the time of his death a member of the Legion Membership Council. In Dave's memory, National Branches District has created 'The David Street Award' which is to be awarded annually to an individual for services to the District. In line with NBD practice in this first year of the award, it was made to Dave Street (RIP) himself and presented to his widow Jackie and daughters Poppy and Hettie. The award was presented by Legion Chairman Jason Coward during the NBD Annual Conference at the NMA on 20 January 2024. Jackie thanked the district for remembering and honouring David in this way and said how proud and pleased he would be.

Our Branch Standard was on parade at the dedication of a new Standard for the NBD which was spoiled in the rain at funeral of HM Queen Elizabeth The dedication ceremony took place in the NMA Chapel and the Branch was represented by chairman Jim McDermott and John Swann Branch Treasurer with Dave Lawrence a fine job parading doing Standard. The NMA padre led the ceremony: also darted he off frequently to switch music on and off and half way through the service asked if anyone had a match so he could light the candles on the altar. The formality of the occasion was enhanced by the playing of Last Post and Reveille by a Royal Marines bugler.

## NATIONAL BRANCHES DISTRICT ANNUAL MEETING

The NBD Annual Meeting was held at the NMA on Saturday 20 January 2024 - the meeting is the equivalent of a County Conference. The Branch was represented by delegates Dave Lawrence and John Swann. John delivered our Branch report for 2023 which was well received. Legion Chairman Jason Coward gave a corporate address and reiterated the need for Legion members to carefully consider the proposals for changes to Legion governance which will be tabled again at the National Legion Conference in 2025.

Jane Britton, Head of Community Development gave a talk on a Legion project in which comedy is used as a form of therapy.

#### **UK NUCLEAR WEAPONS TESTS**

Over 20,000 military personnel were present at the UK nuclear weapon tests between 1952 and 1967 in Australia and the South Pacific. The tests were the largest tri-service event since the D-Day landings. Nuclear Test Veterans, who believe they have suffered ill health due to service can apply for no-fault compensation under the War Pensions Scheme which has no time limits and a low standard of proof. War Pensions are payable in respect of illness or injury due to Service in HM Armed Forces before 6 April 2005, with the benefit of reasonable doubt always given to the claimant. Decisions are medically certified and follow consideration of available service and medical evidence, where evidence supports a causal link to service, entitlement will be given. Veterans UK have worked with The British Nuclear Test Veterans Association (BNTVA) to develop enhanced guidance to support claimants belonging to the Veterans Nuclear Test community.

Following a lengthy campaign a medal has now been struck for those involved in the nuclear tests. The medal's design features an atom surrounded by olive branches, with the words "Nuclear Test Medal" and bears an image of His Majesty King Charles III on the reverse. The medal's ribbon colours are white, yellow, black and red, including a lighter blue for the sky and ocean to represent the Pacific The medal is a commemorative medal and not a campaign medal. Veterans, civilian staff and next of kin can apply for a medal free of charge; it will also be awarded posthumously.



The Nuclear Test Medal is awarded to UK Service and civilian personnel, and individuals from other nations, who served at the locations where the UK atmospheric nuclear tests were conducted, including the preparatory and clear-up phases, between 1952 and 1967 inclusive.

This includes the following named tests:

- (1) Operation HURRICANE
  - (2) Operation TOTEM
    - (3) Operation MOSAIC
      - (4) Operation BUFFALO
        - (5) Operation GRAPPLE
          - (6) Operation ANTLER

The Medal is also awarded to UK personnel who served at locations where American atmospheric nuclear tests took place in 1962 under Operation DOMINIC.

#### **UK NUCLEAR WEAPONS TESTS**

Here's a veteran's first-hand account of the testing, sent to us courtesy of North Weald RBL Branch member Jon Schlanker, who has strong links to the Y Services.

In 1956 I was called up to do National service in the RAF. I was drafted in to the balloon unit at Cardington. In 1957 I was sent with our unit to Maralinga in Australia for atomic tests using our barrage balloons. I was the driver of the winch that had the balloon on it and underneath the balloon was a basket which we put the atomic bomb in. The bomb was the size of a football but packed a horrible punch.

I hoisted the balloon to 800 feet, got into my jeep with other crew members and drove to the top of a hill 6 miles away. We saw the bomb go off but after a few moments panic set in. The wind had changed and forced the radioactive dust to blow our way. Though we had some protective clothing on it was not enough to stop us getting covered in it. We were all radioactive. We went in to a large shower room where we were scrubbed down and then into hospital for a month before getting the all clear. We then had 6 weeks R and R in Adelaide to get over it. All these tests were done for the good of this country and I agree it had to be done and I had no say in it but all the necessary precautions were not taken. There were 22000 of us out in Maralinga and Christmas Island and today there are just 2000 of us left.

My badge and medal and some tatty bit of paper arrived 2 days ago. The box was pushed through my letter box and dropped on the floor. I was disgusted with the government and Ministry of Defence for the way they presented it to us. The medal has no inscription on it, it should have my name & service number at least. This is an insult to us survivors but more importantly to all our friends who have lost their lives due to the radiation. Most of them got cancer, leukaemia or other killing illnesses.

#### **COMMEMORATIVE MEDALS**

Bigbury Mint, one of the UK's largest commemorative medal producers, say that they are often asked if serving armed forces personnel and ex service personnel are allowed to wear commemorative medals. In the United Kingdom the policy for serving personnel is quite clear; Armed forces personnel must not wear commemorative medals whilst serving. Ex service personnel can wear commemorative medals in a row underneath any official military medals. There is no official policy as such; however, conversation with the MoD has confirmed this approach. Commemorative Medals have usually been manufactured to commemorate some form of service, usually where no recognition has been previously given. They have grown in popularity over the last twenty five years or so. Many veterans proudly wear commemorative medals underneath their official military medals or as stand-alone medals. The following extract from the Legion Ceremonial Handbook states:

'The official rules for wearing medals allow only official awards to be worn. Unofficial purchased medals and foreign medals which do not have the Sovereign's permission to be worn are not allowed. Standard Bearers, Parade Marshals and other officials on Legion duty are bound by this ruling and unofficial medals must not be worn when on Legion duty.'

We have **120** members participating and since we ioined the scheme, in 2016, a total of £2724.42 has been raised and all for free!


